PASTORAL CHURCH BUILDINGS SCHEME

This Scheme is made by the Church Commissioners ("the Commissioners") this 20th day of February 2022 in pursuance of the Mission and Pastoral Measure 2011, the Right Reverend Martyn, Bishop of Leicester, having consented thereto.

Part I

Declaration of closure for regular public worship

1. (1) The church of Saint Giles, Stretton Magna, being a chapel of ease in the parish of Great Glen in the diocese of Leicester, shall be declared closed for regular public worship by this Scheme.

(2) The marriage register books (if any) appertaining to the said church shall be dealt with in accordance with section 62 of the Marriage Act 1949 and, subject to any provisions of the Parochial Registers and Records Measure 1978 that apply thereto and any directions thereunder, any other register books and records of that church which remain in parochial custody shall be dealt with as the Bishop shall direct.

Part II

Coming into operation of this Scheme

2. (1) Part I of this Scheme shall come into operation upon such date as the Commissioners, after consultation with the Bishop, shall determine.

(2) Part II of this Scheme shall come into operation upon the date on which it is made by the Commissioners.
